That I will hold allegiance to the said Supreme Council and be loyal thereto, as the supreme authority of the R illegal and spurious every other Body that may be established within it's Jurisdiction, claiming to be a Supreme Council; and every other Body of said Rite with the same jurisdiction that does not hold from said Supreme Council, and will hold no communication whatever in Scottish Rite Masonry with any member of the same nor allow him to visit any Body of the Rite of which I may be a member dispense justice to my brethren according to the laws of equity and honor. Should I violate this my solemn tow and pelege, I consent to be expelled from Scottish Rite Masonry, and all rights therein, and to be denounced to every Body of the Ancient Accepted Scottish Rite in the world as a traitor and forsworn.
